#### **NOTIFICATION**

In pursuance of Governor's Secretariat, Bihar Letter no.BSU-25/84-3965/GS (I) dated 20.12.1986, the Vice Chancellor has been pleased to constitute the different statutory Committees of the Patna University subject to the following condition:

The term of membership of the committee other than ex-officio members may be three years from the date of their nomination provided that a member nominated as a representative of any body, shall be deemed to vacate office with effect from the date on which he ceases to be the member of that body.

(i)The Vice-Chancellor may, if he so desires, authorize the Pro-Vice-Chancellor or a senior Dean of a Faculty to preside over any meeting of any committee, as and when so needed.

(ii) The Registrar may, if he so desires, authorize any other officer of the university to act as Member Secretary of any meeting of any of the Committees in which he/she is the Member Secretary.
