- Taking initiative for joint National & International Projects.
- Work towards public policy, sustainable development and community services.
- Any other activities viewed to be potentially beneficial.

#### Under this MoU Both Parties mutually Agree to:

- Adoption, adaption, and exchange of academic programmes in the broad areas of mutual interest and related disciplines focusing on the blended and digital learning process.
- ii. R&D collaborations in the academic and ODL areas.
- iii. Assisting each other for the organization and / or participation in national and international symposia, conferences, specialized exhibitions and similar events taking place in the respective places.
- iv. Joint collaboration for development & promotion of OER (Open Educational Resource) and MOOCs (Massive Open Online Courses).
- v. Sharing technology for effective e-learning, m-learning and online student support services including evaluation of student's performance.
- vi. Sharing of best practices in the field of programme design, development and delivery.
- vii. Promotion of Skill Development Programmes to boost employment opportunities for our learners, particularly the under-privileged groups
- viii. Joint collaboration for Faculty Development Programme that will include classroom seminars and site visits which may include trips to Learner Support Centres, Regional Centres, historical places, museums, educational institutions, Non-Governmental Organizations (NGOs), villages, etc.
- ix. All other relevant activities of mutual interest to both the parties, Part-I & Part-2
- x. Seek opportunities for funding for projects of mutual interest.

### Terms of Implementation Renewal, Revision

- 1. Details of the implementation of any particular exchange resulting from this MoU shall be negotiated between the two universities.
- 2. This MoU will become effective on the day it is signed and remain valid for five years.
- 3. This MoU will be renewed after five years upon the consent in writing of both universities. Each university may cancel the MoU by notifying the other University of its intent to do so at least six months in advance of its expiration. Projects in progress at the time of termination will remain unaffected.

- 4. Any amendment or modification to the present text shall be submitted for review to the competent authorities, and shall not binding unless reduced to writing and signed by both the universities.
- 5. This MoU does not presume nor require and mutual financial transaction inbetween, both parties acknowledge and understand all financial arrangements, if any, will be subjected to prior written agreement and availability of funds for each activity / project undertaken.
