## REGULATION FOR POST GRADUATE DIPLOMA COURSE IN CLINICAL PSYCHOLOGY



1. An examination shall be held for the grant of P.G. Diploma in Clinical Psychology.

### 2. QUALIFICATION FOR ADMISSION

Any registered student of the University, who has passed the M.A. examination in Psychology with a special paper in Clinical Psychology of this University or an examination recognised by the Academic Council as equivalent thereto, taking Clinical Psychology as a special paper, may be admitted to the examination if he has completed a regular course of study for a period of one academic year. For admission to the course, the marks obtained at the M.A. or any other equivalent examination in Psychology and the marks obtained by the candidate a Viva-Voce examination (Full marks 100) conducted by the Institute of Psychological Research and Service, Patna University, Patna shall be taken into consideration to be added in his/her marks obtained at the M.A. or any other equivalent examination to determine his/her position in the merit list.

3. The fee payable by a candidate for admission to the University examination shall be three bundred rupees.

4. Every candidate shall be examined in the following subjects:

### METHOD OF CONDUCTING EXAMINATION

5. The examination shall be conducted by means of papers, 4 in theory carring 100 marks each of three bour duration and papers 2 of practical carrying 100 marks each of four hour duration.

6. In order to pass a candidate must obtain 45 percent of the agregate marks in written papers examination and 45 percent of the aggregate marks in practical papers examination separately.

Candidates who obtain in the aggregate 60 percent or more shall be placed in the first class. Candidates who obtain in the aggregate 45 percent or more marks but below 60 percent marks shall be placed in the second class.

### PUBLICATION OF RESULT

7. As soon as possible, after the examination, the Examination Board shell publish a list of successful candidates, placed in the first or second class, arranged in order of serit.

8. Every successful candidate will be swarded a delices in such form as the Academic Council may approve.

Other provisions not covered under present regulation shall be governed by regulation for other P.G. Diploma courses of the Patra University.

- 2. Admission to the P.G. Diploma in Clinical Psychology course shall be made on the basis of the marks obtained at the M.A. Examination to which marks obtained at the interview carring 100 marks will be added to compute the merit list.
- 3. The number of seats in the P.G. Diploma course in Clinical Psychology shall be 20.
- 4. The reservation of seats for the course shall be as per rules of the Patna University contained in notification/Memo No. G/926, dated 31-7-1996 as montioned below:
  - A. Scheduled Caste 14% of the total sanctioned seats.
  - B. Scheduled Tribe 10% of the total sanctioned seats.
  - C. Extremely Backward Classes- 14% "
  - D. Backward Class 10% of thettotal sanctioned seats.
