GULATIONS FOR POST-GRADUATE DIPLOMA COURSE IN WOMEN'S STUDIES

- Admission to the course shall be open to candidates who possess

 Honours Graduate degree in any discipline or equivalent.
- Admission to the Course shall be made on the basis of marks obtained at Graduation level and an interview conducted by the History Department.
- 3. The number of seats shall be 60 only.
- The Reservation of seats belonging to various categories shall be as per Patna University/Bihar Government rules.
- 5 Examinations :-
 - (a) Only a student registered with Patna University after admission in this course will be eligible for appearing in the examinations.
 - (b) There shall be one annual examination at the end of the academic year but two periodical tests will be conducted for proper appraisal of student's progress and marks allotted therein will be aggregated marks obtained in Annual Examination.
 - (c) Periodical tests will be conducted in the shape of seminar, group discussion, assignment and presentation.
 - (d) There will be eight papers altogether. The first seven papers will be theory papers and the 8th paper will consist solely of Project and Field Work.

Distribution of Marks

- (a) The split of marks shall be as follows:
 80 marks each theory paper plus 20 marks for periodical Tests.
- (b) Students will have to secure atleast 45% marks to pass the examination. A candidate securing 60% and above as aggregate marks will be awarded, a first class and those securing below 60% but above 45% ill be awarded second class. Anybe assecuring 75% and above will be declared first class with listinction.

- (c) In case a student fails in more than three papers he/she will have to repeat the course on payment of required fee. Otherwise, he/she will be allowed to clear those papers in the next examination.
- 7. Attendance: 75% attendance is compulsory for appearing in the examination.
- 8. The Vice-Chancellor will appoint a Board of Moderators and all the examinations conducted and the results published will be under the Examination Board, Patna University.
- Wherever this regulation is silent such matter will be governed by the regulation already existing.

ORDINANCE FOR ADMISSION TO POST-GRADUATE DIP OMA COURSE IN WOMEN'S STUDIES

Admission to the course shall be open to candidates who possess Honours Graduate degree in any discipline or equivalent.

Admission to the Course shall be made on the basis of marks obtained at Graduation level and an interview conducted by the History Department.

The number of seats shall be 60 only.

The Reservation of seats belonging to various categories shall be as per Patna University/Bihar Government rules.

The course is designed as no profit, no-loss basis and the proposed fee-structure for the full course is as follows.

Rs. 100/-Admission fee Rs. 7000/-Tuition fee Rs. 1000/-Library fee Rs. 8100/-Total

Thus, total fee paid by the students of different categories shall be as frilows :

Rs. 8100/-For General Candidates Rs. 7100/-For BC (I) Candidates

Rs. 5100/-For SC/ST Candidates

Each candidate shall have to pay Rs. 800/- (Eight hundred arrly) :-Annual Examination Fee.
