We would like to thank you for presenting your CRS proposal at Indus Synchrotron Users' Meeting (ISUM-2) during $30^{th}-31^{st}$ July, 2020. Subsequently the proposals were discussed at length by a Committee. Your above proposal has been approved:

The financial allocation for this year will be: Project Fellow (@ Rs.14,000/- pm) + HRA Contingency Consumables

Rs.15,000/-Rs.30,000/-

No overheads are available under this scheme.

1. This project is sanctioned presently for one year but it may be extended on year basis subject to a total period of three years. The project will be reviewed at the end of each year and a decision will be taken on the financial allocation for the succeeding year.

2. This proposal is assigned to BL02 of Indus-1. Dr. R.J. Choudhary from UGC-DAE CSR will

coordinate your project.

- 3. This is a Collaborative Research Scheme. In view of the complex and involved nature of the experiments, any publication emerging under the project must be of collaborative in nature with due consents from the participating institutions / persons, and in consultation with the CRS coordinator. The publication should also acknowledge the UGC-DAE CSR, Indore for the project support.
- 4. The CSR will be able to reimburse the travel expenses to investigators as per rules, limited to 2nd AC train fare visiting CSR, Indore Centre on project work. However, the student participant is permitted for a sleeper class train fare by the shortest route and is as per prevailing norms of CSR.
- 5. The PI along with the co-ordinator from CSR side are requested to make every effort to complete the project in time.

- 6. At the end of the financial year (i.e., March 31) you will kindly send the (i) utilization certificate for the amount spent and (ii) a statement of account duly signed by the Registrar of your university to the Centre-Director, Indore Centre of UGC-DAE CSR. Funds for the succeeding year in view of the allocation can be released only after receiving the above documents.
- 7. Selection of research student in the project will be done as per the guidelines given below. The PI may contact Centre-Director of Indore Centre for approving the CSR Nominee for the selection of the candidate. The Research student must be registered for a Ph.D. from a recognized University in their respective disciplines in a reasonable period of time after joining the project.
