



This has reference to our earlier letter, emails regarding pertaining to alleged ragging incidents reported by the NGO Helpline.

In our letter dated 22.8.2017 we had requested the NGO Helpline to disclose the name of the victim and culprit with the actual date and time of occurrence if any so that we may take action. The Anti Ragging and Anti Racial Helpline was calling us and writing us without disclosing the name of the victim or culprit with the actual date and time of the occurrence. The anti-Ragging Committee has enquired about the incident but no case was reported or filed or there were no evidence of such occurrence in and around the Mahavidyalaya.

For your kind information, we have taken measures to prevent ragging menance in the Mahavidyalaya by wall writing, poster writing, Notice on the Notice Board, CCTV camera in the class room and in the campus:

We, therefore, request you kindly to look into the matter by examining the reply and action taken by the college and stop misuse of the UGC regulation on curbing the menace of ragging in higher educational Institutionals, 2009. The NGO Helpline has been torturing us in the past years when Dr. Umesh Mishra Was the Principal of the college. If there is no incident or ragging case in the college, how can we take action and against whom?

We, therefore, request you kindly to drop this case as it is not admissible to take action.

We have enquired even from the CCTV camera and there are no cases reported in the college by any boy or the girl student. How can we give punishhment to the culprit? When there is no case of ragging, Do we give punishhment to the imaginary culprit like the NGO Helpline.

Therefore, we are tired of receiving imaginary complaints from the NGO. We think the NGO is creating imaginary cases for the survival of the NGO. We feel that it is the mental & physical torture of the members of the anti-ragging committee by the NGO Helpline for Anti-Ragging & Anti Racial Abuse. Therefore, we request you to make us free from the Anti-Ragging Committee & give us relief.

- v. Violation of decency and morals through ragging;
- vi. Injury to body, causing hurt or grievous hurt;
- x. Assault as well as sexual offences or unnatural offences;
- xi. Extortion;
- xvii. Physical or psychological humiliation;

The following decision were taken for action on 02.07.2018 in the second meeting. (1) A letter be sent to the applicant through the superintendent Nadvi hostel to appear before the Committee for detailed interrogation. (2) The In-charge of the police post in Patna College Campus be inquired about the reported incident. (3) The boarders of the Nadvi hostel be inquired about the incident. (4) A letter be sent to HOD Physics, Patna University where the complainant is Students. Reports and action taken (1) The superintendent informed that the complainant is not present in the hostel He contacted him on telephone and the boy concerned told him that he is now a days in Bengaluru. He farther said that he has nothing to say now in this connection (2) The P.S. In-charge Sri R.K. Yadav informed that he has no report about any such incident. (3) Some boarders of Nadvi Hostel also denied any such incident. It was further reported that on 4th of June 2018 there was an Iftar Party in the hostel which was attended by many dignitaries including the V.C. of the University but no such incident was brought to his notice by anyone. (4) The HOD Physics Patna University replied nothing till now. Considering all the points the Committee came to a conclusion that unless the complainant mention some specific names nothing can be traced out. Any how the police personnel of the local police post are advised to take more care of the law and order situation during the day time also. The superintendent is also advised to look into the matter minutely and if he gets any clue about the incidents it should be reported to the Dean Students Welfare, Patna University who happens to be the in-charge of Nadvi Hostel. Another meeting of the Anti-Ragging Committee was held on 12.07.2018. After reviewing the latest situation it was resolved that as desired detailed report be sent to the Anti-Ragging Cell with a copy to the Proctor, Patna University within a week.
